3. Sealed bid must be submitted to the office Sunchhahari Rural Municipality by on or before 12 hours (Local Time) on 24th Bhadra 2077. Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13 hours on 24th Bhadra 2077 at the office of Sunchhahari Rural Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRs.25,000.00** which shall be valid for 30 days beyond the validity period of the bid (i.e. 10th Mangsir 2077). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No: 43525240600003, at Nepal SBI Bank Ltd, Sunchhahari, Rolpa, or in any A Class Commercial Bank accredited by Nepal Rastra Bank and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
